D. REGISTRATION

The General Directorate of Environmental Health authorizes the registration or e-registration in the Sanitary Registry of Food and Beverages for Human Consumption of the products described in item C under the following conditions:

- a. The company and its legal representative are jointly and severally responsible for ensuring that the products described in item C are placed on the national market in safe conditions and suitable for human consumption.
- b. The product container must record the Sanitary Registry Code, the manufacturing batch and the expiration date of the product.
- c. Any change or new design in the packaging, packaging, presentation or labeling will only require a notification to DIGESA, which will automatically incorporate said change in the Registry.
- d. The validity of this registration or re-registration authorization in the Sanitary Registry of Food and Beverages is five years from the date of its issuance.
- e. This registration is subject to health surveillance and monitoring by DIGESA, which may revoke it.
- f. The company is obliged to notify DIGESA in writing of any change or modification in the data or conditions under which the Sanitary Registration was granted to a product or group of products, at least seven (7) business days before it is carried out, accompanying the precautions or information that supports said modification.
